经甲方(客户)与乙方(中国工商银行 XXX 分/支行)协商一致,就乙方代中国工商银行(美国)(以下简称"工银美国")为甲方办理开户见证业务达成如下协议:

一、 甲方自愿申请使用乙方提供的代理工银美国开户见证业务相关服务,并同意遵守本协议的各项约定。

二、基本规定

- (一) 代理工银美国开户见证业务是指乙方审核甲方提供的在工银美国开户所需资料,对甲方所提交的开户资料及甲方签名提供见证服务。
- (二) 乙方仅为甲方在工银美国开户所提供申请资料的完整性提供见证服务。甲方的账户开立在工银美国,在使用账户过程中产生的问题,由工银美国负责与甲方协商解决。
- (三) 甲方在工银美国开立的是存款支票账户。
- (四) 甲方同意将本人办理上述账户开户的个人开户信息和申请资料由乙方传递或邮寄给工银美国。

三、 代工银美国开户见证业务的办理

- (一) 甲方确定,在办理代工银美国开户见证业务前已经阅读并明白适用于工银美国开立账户的条款,包括个 人账户条款、网上银行条款以及银行服务收费条款,并同意接受上述条款的约束。
- (二) 甲方需向乙方提供本人有效身份证件、护照、签证或签证办理证明,以及乙方要求提供的其他办理开户 见证业务所需资料,并承诺所提供的资料真实、有效,如有伪造、欺诈需自行承担相关法律责任。甲方 只能为本人办理开户见证业务,不得代他人办理本业务。
- (三) 乙方将为甲方所提供的账户申请资料及签名提供开户见证服务,并及时将相关开户信息和申请资料传递或邮寄给工银美国。在开户过程中如出现任何问题,工银美国可在乙方的协助下直接与甲方交流。
- (四) 甲方可通过乙方申请在工银美国开立存款支票账户、申领借记卡、支票簿等服务,工银美国审核后为甲方开立账户。客户开户确认书由工银美国直接发电子邮件给客户。甲方抵达美国后,应确保至少 100 美金到账后前往工银美国网点领取借记卡、支票簿(如申请,正式支票本有费用),或者甲方联系工银美国网点更新在美地址后,由工银美国相关人员寄送至甲方提供的美国地址。
- (五) 甲方知悉工银美国对其开户申请具有独立的审核和最终决定权,乙方对甲方是否可以在工银美国成功开户不承担任何法律责任。
- (六) 客户应在开户成功后 60 天内向该账户汇款,否则工银美国将询问客户原因,并保留关闭该账户的权利。

四、 代工银美国开户见证业务项下相关业务的办理

- (一) 账户成功开立以后,乙方见证开户的职责已完成。甲方可自行登录工银美国的网址注册网上银行。如有任何账户相关的问题,甲方应直接与工银美国联系。
- (二) 甲方办理已开立账户的撤销(关户),应本人直接与工银美国联系。

五、 代工银美国开户见证业务相关费用收取

甲方向乙方申请办理代工银美国开户见证业务时,需向乙方交纳见证手续费人民币贰佰元。开户申请受理后需经工银美国审核,无论账户开通与否,见证手续费都不予退回。此费用不包括工银美国根据自身规定向甲方收取的与其提供服务相关的费用。

- 六、 本协议未尽事宜,由甲乙双方协商解决,协商不成的,在乙方所在地法院诉讼解决。本协议适用中华人 民共和国法律。
