Terms and Conditions for Vehicle Financing Services

- 1. I confirm that all information given above is true and complete and authorize Industrial and Commercial Bank of China (Asia) Limited ("the Bank") to make any enquiries which it considers necessary or to verify the information from whatever sources it may choose for confirmation and credit assessment. I understand that if I knowingly make any false statement in my application with an intention to deceit, I may be liable for criminal prosecution.

- 3. I also agree that all personal data relating to me may be used and disclosed for such purposes and to such person (whether in or outside Hong Kong) as may be in accordance with the Bank's policies on use and disclosure of personal data set out in statements, circulars, notices or terms and conditions made available by the Bank to its customers from time to time and such data may be used in connection with matching procedures (as defined in the "Personal Data (Privacy) Ordinance"). - 6. I understand that the Bank has the sole and absolute discretion to decide whether to accept this application and all matters relating to the application including the loan amount to be granted and the repayment period without the need to assign any reason for its decision(s).
- 7. I agree to inform the Bank as soon as possible of any difficulty in repaying or servicing the loan over the credit period.

The Bank has provided me/us the options to take out the comprehensive insurance for the car on the basis of either its market value or the loan amount and I am aware of the related valuation and extra costs or fees (if applicable). I understand my option of choosing the insurer is subject to the Bank's approval and may involve extra procedure and charges.
- 9. The Bank has reminded me of my right to employ separate legal representation at my/our own cost but the firm of solicitors to be employed is subject to the Bank's approval.
- 10. I authorize the Bank to provide an individual proposing to give a guarantee or third party security (the surety) with a copy of facility letters, statements of accounts, overdue payment reminders and demand letters.
- 11. In making this Declaration, I have either sought independent professional/legal advice, or I have decided not to do so and voluntarily waive such defence for making the Declaration without additional independent professional/legal advice.
