- (g) appropriate computer equipment and software, internet access, a specific internet banking account and designated email address are required for using the e-Statement Service;
- (h) email will be the only notice that the e-statement has been posted on the Bank's website. I undertake to check the designated email address and Bank's website regularly to ensure there is no delay in receiving the e-statement.
