This Cookie notice provides you with information about the cookies we use and the purpose for which we use them.

### 1 What are cookies?

Cookies are small files stored by your browser when you visit our website. They are used in order to make websites work, or work more efficiently, as well as to provide information to websites' owners on the use of their website.

### 2 The cookies we use

We use cookies to improve the user's navigation experience. More precisely, our cookies are used for the following purposes:

• Security reason: in order to assess whether our website is subject to a cyber-attack, detect defaults, fraud and/or abuse.

• Performance of our website: in order to propose a smooth navigation on our website.

Please note that all used cookies are first party cookies. We do not use third party cookies. The features of the cookies used on the website are illustrated in the table below, including cookie name, cookie type, data collected, cookie duration and purpose.

# 4 What legal basis do we have to process your personal data when using cookies?

The legal basis we rely on to process your personal data is article 6(1)(f) of the GDPR, which allows us to process personal data when its necessary for the purposes of our legitimate interests.

### 5 Cookies and your privacy

The information cookies collect, and how we use that information, may count as personal data. We may also be able to identify you by name, IP address or session ID. You have rights regarding how we collect, store and use your personal data.

You have the following rights with respect to your personal data collected through cookies:

- Right of access to your personal data,
- Right to have your personal data corrected,
- Right to have your personal data erased,
- Right to limit certain processing operations,
- Right to data portability,
- Right to object to certain processing operations,
- Right to withdraw your consent.

If you believe that the processing of your personal data does not comply with the applicable legislation and/or that we have not acted on your request, you have the right to file a complaint with the Belgian Data Protection Authority.
