## Notice regarding the Adjustment of the HKD, MOP, USD Loan Prime Rateand Savings Rate

In response to the US Federal Reserve policy action of raising US Fed Funds Rate target range by 75 basis points on 2<sup>nd</sup>November 2022 (US time), Industrial and Commercial Bank of China (Macau) hereby announces that effective on 4<sup>th</sup>November 2022, the HKD, MOP, USD loan prime rate and savings rate will be adjusted. In particular, the HKD and MOP loan prime rate will be increased from 5.375% p.a. to 5.625% p.a., and the savings rate will be increased from 0.125% p.a. to 0.375% p.a..
