ICBC Malaysia UnionPay Card Usage Program Promotion Terms and Conditions

Industrial and Commercial Bank of China (Malaysia) Berhad (Company No. 839839-M) ("ICBC Malaysia") is running a "UnionPay Global Cash Rebate Program" ("Promotion") from 1st February 2019 to 28th February 2019, both dates inclusive ("Promotion Period") or until such time as determined by ICBC Malaysia.

Eligibility

- 1. The Promotion is open to UnionPay Credit Card and Debit Card cardholders issued by ICBC Malaysia who fulfilled the conditions in Clause 2 ("Eligible Customer")
- 2. The customer as follows shall be eligible to participate in the Promotion:
 - 2.1. UnionPay Credit/Debit Card principal and supplementary cardholders issued by ICBC Malaysia.
- 3. The following customer shall not be eligible to participate in the Promotion:
 - 3.1 Customer who has cancelled the card before cash back payout.

Promotion Mechanism and Conditions

- 1. 10% cash back rewards will be given to Eligible Customer who has accumulated minimum spending of RM 300 in a calendar month during the Promotion Period.
- 2. Total spending accumulated during the calendar month shall be taken into account for the 10% cash back payout. Eg: Spending in February cannot be accumulated with spending in March for payout.
- 3. Only transaction which is recognized by ICBC Malaysia shall be accounted for cash back calculation as Qualified Transaction. Likewise the scope of ("Qualified Transaction") shall include:
 - 3.1. Transactions on cards with UnionPay BINs ("Bank Identification Number") shall be switched only through the UnionPay System or other channels approved by UnionPay International Co., Ltd.

- 3.2. POS and e-Commerce Transaction as recognized by UnionPay network transactions.
- 3.3. Any qualifying transaction which is subsequently cancelled or refunded for whatever reason will not qualify for the Promotion.
- 3.4. All transactions made during the Promotion Period must be posted and captured in the issuing Bank's system in order to gualify for the Promotion.
- 3.5. Cash withdrawals/ cash advance will not constitute as transaction.
- 4. For avoidance of doubt, the example below will illustrate the respective payout to Eligible Customer.

10% Cash Back Payout Mechanism

Spent RM 300 using ICBC UnionPay RM 35 as both transactions carried out as Credit Card on 15th February 2019 and accumulated spending throughout the calendar

10% Cash Back Payout Mechanism

Spent RM 400 on 28th February 2019 and RM 40 as the payout only recognizes subsequently spent RM 100 on 2nd March accumulated spending incurred in single calendar month during Promotion Period.

10% Cash Back Payout Mechanism

Spent RM 5000 on retail purchase on 1st RM 100 as maximum payout is capped at RM 100.

- 5. Maximum payout for every principal cardholder and supplementary cardholders will be capped at RM 100 each per month.
- 6. Cardholder will only be entitled for (1) time cash back reward during the Promotion Period. Should the cardholder cancel the card before cash back payout, they will be deemed as forfeited the right to participate in the Promotion.
