Eligibility

1. The Promotion is open to all new and existing ICBC Malaysia individual customers including Malaysian and non-Malaysian customers, and corporate customers including but not limited to sole-proprietorship, partnership, charitable/none profit organization/societies, corporate and commercial customers who is participating the Promotion at ICBC Malaysia Johor Bahru Branch. ("Eligible Customers"), unless notified otherwise.

Promotion Mechanics and Conditions

- 2. The Promotion shall involve products distributing by ICBC Malaysia as comprise below:

12-months MYR Fixed Deposit

Unit Trust ("UT")

16. Eligible Customers may enjoy promotional discount rate of 50% off from normal upfront sales charge ("Promotional UT Rate") for unit trust products distributed by ICBC Malaysia.

Physical Precious Metal

- 21. Eligible Customers will be able to enjoy precious metal discount from the normal price ("PM Discount") on the purchase of ICBC Malaysia Precious Metals as shown on the tier-based table below.

- 22. For avoidance of doubt, Eligible Customers may accumulate various ICBC Malaysia Precious Metal products to be entitled for next higher tier so long as the purchases are made within same purchase on 1 ("one") visitation to ICBC Malaysia.
- 23. PM Discount is subject to while stock last and first-come-first-serve basis.
- 24. Eligible Customers shall only choose either 1 ("one") tier to participate within the same purchases.
- 25. ICBC Malaysia Precious Metals are not protected by Perbadanan Insurans Deposit Malaysia ("PIDM").

Promotional Home Loan (PHL) Refinancing Rate

26. Eligible Customers who apply home loan refinancing facility with ICBC Malaysia during the Promotion Period will be eligible for the PHL Refinancing Rate.
