Eligibility

- (1) New customer aged over 18 (Refer to "Terms and Conditions for New Customer Account Opening");
- (2) Nationality (Country/Region) of China(Hong Kong) /China(The Mainland)/ China(Macau)/ UK/ Canada/ Australia/ New Zealand.;
- (3) You should hold a valid Hong Kong Identity Card (HKID).Holding valid new smart Hong Kong Permanent/Non-permanent Identity Card introduced before 26 Nov 2018 (Customers who have changed name before are not supported at the moment);
- (4) Provide Taxpayer Identification Number (TIN);
- (5) You should not be a tax resident of The United States of America.
