- Visa Dual Currency Credit Card

IMPORTANT:

PLEASE READ THIS CARDHOLDER AGREEMENT THOROUGHLY BEFORE USING OR SIGNING A CARD OR USING ANY OF THE SERVICES. BY USING OR SIGNING OR RETAINING A CARD OR USING ANY OF OUR SERVICES, YOU WILL BE DEEMED TO HAVE ACCEPTED ALL THE TERMS AND CONDITIONS CONTAINED IN THIS AGREEMENT AND WILL BE BOUND BY THEM. YOUR USE OF THE CARD WILL BE GOVERNED BY THIS AGREEMENT. IF YOU DO NOT WISH TO BE BOUND BY THIS AGREEMENT, CUT YOUR CARD IN HALF AND RETURN THE PIECES TO US. UNLESS YOU DO SO, WE WILL ASSUME THAT YOU HAVE ACCEPTED THIS AGREEMENT.

1. Definitions

In this Agreement, the following words shall have the following meanings, unless the context otherwise requires:

- "Account Holder" means a person in whose name the Card Account is opened and maintained:
- (b) "Balance Transfer" means a transfer of the debit balance on any credit card held with any credit card issuer or any account with other banks (other than a Bank) to a Card Account:
- (c) "Bank" means ICBC (Asia) with respect to the Hong Kong Dollar Card Account or ICBC with respect to the Renminbi Card Account:
- (d) "Bank Group Company" has the meaning given to it in the Data Notice;
- (e) "Card" means any dual currency credit card comprising a Hong Kong Dollar Card Account and a Renminbi Card Account, whether a principal, supplementary, or corporate card, whether "platinum", "gold" or "classic", and including a generic or affinity or "co-brand" card, issued by ICBC (Asia) (for itself and/or on behalf of ICBC) pursuant to this Agreement;
- (f) "Card Account" means either the Hong Kong Dollar Card Account or the Renminbi Card Account, or a specific one of them as the context may require;
- (g) "Cardholder" means a Person in whose name a Card has been issued and, where the context permits or requires, includes a supplementary Cardholder, any of their respective personal representatives and lawful successors (but may or may not include the Account Holder as the context may require);
- "Card Transaction" means any purchase of goods and/or services or any transfer or cash advances effected by the use of a Card;
- "Charge" means any amount debited to a Card Account as shown on the Statement;
- "Credit Reference Agencies" means any data user who carries on a business of providing consumer credit reference service, whether or not that business is the sole or principal activity of that data user;
- "Data" shall be as defined in the Personal Data (Privacy) Ordinance (Cap. 486) of the Laws of Hong Kong and any codes of practice issued pursuant to this Ordinance;

- "Data Notice" means ICBC (Asia)'s "Circular to Customers and Other Individuals relating to the Personal Data (Privacy) Ordinance" from time to time revised and circulated to customers:
- "Fee Schedule" means the schedule setting out the annual fees, cash advance handling fee, late charge, interest and other fees and charges from time to time in force and applicable to the Card;
- "Hong Kong" means the Hong Kong Special Administrative Region of the People's Republic of China;
- (o) "Hong Kong dollars" means the lawful currency for the time being of Hong Kong;
- (p) "Hong Kong Dollar Card Account" means an account in Hong Kong Dollars opened and maintained by ICBC (Asia) for the purposes of recording debits and credits in respect of usage of the Cards under this Agreement;
- "ICBC" means Industrial and Commercial Bank of China Limited:
- "ICBC (Asia)" means Industrial and Commercial Bank of China (Asia) Limited, its successors and assigns;
- "Mainland China" means the People's Republic of China but excluding Hong Kong and Macau;
 - Minimum Payment" means the amount of minimum payment as stated in the Fee Schedule;
- "Payment Due Date" means the date on which the debit balance of a Card Account for any month owed by a Cardholder is payable as specified in the relevant Statement:
- (v) "Person" means any individual, firm, company or other legal or natural person whatsoever:
- "Personal Data" shall be as defined in the Personal Data (Privacy) Ordinance (Cap. 486) of the Laws of Hong Kong and any codes of practice issued pursuant to this Ordinance:
- "PIN" means the personal identification number for the time being supplied by ICBC (Asia) (for itself and/or on behalf of ICBC) enabling a Cardholder to identify himself when using a Card;
- (y) "Renminbi" means the lawful currency for the time being of the People's Republic of China;
- (z) "Renminbi Card Account" means an account in Renminbi opened with ICBC for the purposes of recording debits and credits in respect of usage of the Cards under this Agreement; and
- aa) "Statement" means a monthly statement of account sent by ICBC (Asia) to the Account Holder, setting out the amount then due to ICBC (Asia) and ICBC in respect of both Hong Kong Dollar Card Account and Renminbi Card Account.

Headings are for convenience only and do not affect interpretation. Words denoting the singular shall include the plural, and words denoting one gender shall include all genders.

2. Application of this Agreement

- 2.1 All facilities made available by a Bank to any Person in respect of a Card or a Card Account are subject to the terms and conditions of this Agreement from time to time in force and any other applicable terms and conditions. A Person becomes subject to such terms and conditions (if not already so subject) by signing, activating or using a Card or permitting its use.
- 2.2 This Agreement shall be binding on each successor, personal representative and person lawfully acting on behalf of any Cardholder.

3. The Cards

- 3.1 This Card is not transferable and must be surrendered to ICBC (Asia) immediately upon any Bank's request.
- 3.2 ICBC (Asia) is entering into this Agreement for itself with

Bank shall be obliged to approve the application.
- A Cardholder may apply for a review of his assigned credit limit for the applicable Card Account at any time but neither Each Bank may at its sole discretion (but shall not be obliged to) permit Card Transactions to be effected in excess of the
- credit limit for the applicable Card Account, and a Cardholder (to which the Card Transactions relate) and the Account Holder shall be jointly and severally liable for such transaction in accordance with the terms of this Agreement. Use of the Card
- 5.1 Each Card may be used in respect of the Hong Kong Dollar Card Account at ICBC (Asia) and other financial institutions and merchants (including any Card Transactions within Mainland China which have been converted from Renminbi into Hong Kong Dollars) which accept such Card for effecting purchases of goods and services, drawing of cash advances,
 - payment of a Cardholder's outstanding accounts with any other bank or credit card issuer in Hong Kong other than ICBC (Asia) by way of Balance Transfer and such other credit card facilities or services as ICBC (Asia) may from time to time provide or arrange. Each Card may be used in respect of the Renminbi Card Account at specified Mainland China branches of ICBC, and other financial institutions and merchants using a Renminbi clearing system/Unionpay (within Mainland China only) which accept such Card for effecting purchases of goods and services,

drawing of cash advances, payment of a Cardholder's outstanding

- Renminbi account with any other bank or credit card issuer in Mainland China other than ICBC by way of Balance Transfer and such other credit card facilities or services as ICBC may from time to time provide or arrange. 5.3 A Card may also be used to access a Cardholder's bank account with ICBC (Asia), and such Cardholder agrees that such service shall be subject to any relevant terms and conditions of ICBC (Asia) from time to time in effect in addition to the terms and conditions under this Agreement. Each Cardholder is advised to read through such terms and conditions of ICBC (Asia) before proceeding to use such service.
 - Each Cardholder shall use a Card, and the Account Holder shall ensure that each Cardholder uses a Card: so that the credit limit for each Card Account (including but not limited to any cash advance limit or limit on Balance Transfer amounts) from time to time notified by ICBC (Asia) (for its own behalf and/or on behalf of ICBC) to the Account Holder as applicable to such Card Account is not exceeded; and within the expiry date embossed on a Card.

5.5 A Cardholder's right to use a Card shall be suspended:

if such Card is lost or stolen; or

if any Bank is informed by a Cardholder that the PIN is or may be known to any other Person. The Account Holder and any Cardholder may request that renewal and/or replacement Cards be issued to each

- ICBC (Asia) may at any time in its sole discretion and without giving any reasons, terminate any right of any Cardholder to use his Card to access his bank account with ICBC (Asia).

- 5.10 A Cardholder shall not use a Card or the Card Account for any illegal purposes. ICBC (Asia) (for itself and/or on behalf of ICBC) is entitled, in its sole and absolute discretion, to refuse
- to act on or give effect to any Card Transaction instruction if ICBC (Asia) has reason to believe that such instruction is given in connection with any illegal transaction. ICBC (Asia) (for itself and/or on behalf of ICBC) reserves the right to

Each Cardholder agrees to any Bank (for itself and/or on

behalf of ICBC in case of ICBC (Asia)) recording the telephone

- and of any change in personal or financial circumstances which might be material to a Bank in permitting the use or the continued use of a Card.

- 7.1 As soon as the PIN is assigned by ICBC (Asia) (for itself and/or on behalf of ICBC) to a Cardholder, it shall remain
 - effective until it is cancelled by, or with the agreement of,
 - ICBC (Asia) (for itself and/or on behalf of ICBC). A Cardholder may change the PIN at any time by such means as ICBC
 - (Asia) (for itself and/or on behalf of ICBC) may prescribe and
 - the new PIN shall take effect immediately.
- 7.2 A Cardholder shall not disclose the PIN of a Card to any other Person and shall act in good faith, exercise reasonable care and diligence in keeping such PIN secret.

- If a Cardholder becomes aware that the PIN is or may be known to any other Person, he shall as soon as reasonably

- practicable inform ICBC (Asia) (for itself and/or on behalf of ICBC) or call the Hotline. Such Cardholder shall change the PIN as soon as possible (if applicable). If a Card incorporates
- a facility to enable such Card to be used to access a Cardholder's bank account with ICBC (Asia) using the PIN, such Cardholder shall also as soon as reasonably practicable inform ICBC (Asia) through ICBC (Asia)'s 24-hour Lost Card

- Cardholder following expiry, loss or theft. Neither Bank shall

- (3) any amount due in respect of the use of any other facility or service that ICBC (Asia) may from time to time provide or arrange. The Renminbi Card Account may be debited by ICBC
- for itself for the following Charges:-(1) the amount of any Balance Transfer agreed to by
 - ICBC: the amount of the Card Transactions; and
 - any amount due in respect of the use of any other
- facility or service that ICBC may from time to time provide or arrange. The Card Account may be debited as provided in Clause 8.1 above even though the Charges were incurred (without
- limitation) by (i) telephone, fax, mail order or direct debit authorisation, or (ii) use of a Card over the internet, in an automated teller machine, merchant's point of sale terminal, credit card pay phone or any other facility permitting use of a Card without the execution of a sales draft or the signature of the Account Holder or any Cardholder. ICBC (Asia) (for itself and/or on behalf of ICBC) may at its
 - Account Holder or the Cardholder to promptly pay the Charges on or before the Payment Date or otherwise upon demand by ICBC (Asia) (for itself and/or on behalf of ICBC). Until such requirement or demand, the Account Holder or the Cardholder may make either partial payment or full payment of the Charges on or before the Payment Due Date. The

- minimum partial payment shall be the Minimum Payment. ICBC (Asia) (for itself and/or on behalf of ICBC) may issue a supplementary Card to a Cardholder (other than the Account Holder) at the joint request of the Account Holder and the Cardholder. The Account Holder shall be liable for the use of both the Account Holder's Card and any supplementary
- Cards issued to Cardholders (other than the Account Holder) at the joint request of the Account Holder and the Cardholders. The Account Holder shall be jointly and severally with a Cardholder (to which the Charges relate) liable for the total amount of Charges due to a Bank in respect of the Card Account. Each Cardholder (other than the Account Holder) is also

liable jointly and severally with the Account Holder to a Bank

for total amount of Charges attributable to his own use of a

- Card. ICBC (Asia) (for itself and/or on behalf of ICBC) shall have complete discretion in recovering any Charges incurred by a supplementary Cardholder from either the Account Holder or the supplementary Cardholder or both. The supplementary Cardholders shall not be liable for the use of any Card by any other Cardholder or by the Account Holder. Subject to Clause 11.3 below, a Cardholder's failure to sign any sales or cash advance voucher will not relieve the Account Holder and/or such Cardholder from liability to a
- Bank in respect thereof. 8.7 Charges incurred in or converted into Hong Kong Dollars will be posted into the Hong Kong Dollar Card Account and Card Account.
 - Charges incurred in Renminbi (and not otherwise converted into any other currency) will be posted into the Renminbi Charges in any currency other than Hong Kong Dollars and Renminbi will be converted into Hong Kong Dollars at the prevailing exchange rate determined by ICBC (Asia) (in consultation with, if applicable, any relevant international

10. Payment 10.1 Subject to Clause 10.2 below, payments to the Hong Kong

- Dollar Card Account shall be in Hong Kong Dollars and payments to the Renminbi Card Account shall be in Renminbi. 10.2 Renminbi Card Account payments:
- Payments in the Renminbi Card Account shall be settled in Renminbi at specified branches of ICBC in Mainland China or by other means as advised by ICBC (Asia) (on behalf of ICBC) from time to time.
 - ICBC may (exceptionally but without any obligation) accept Hong Kong Dollars or other foreign currencies acceptable to ICBC for payments to the Renminbi Card Account. In the event of payment in accordance with clause 10.2(b) above, Hong Kong Dollars or foreign currencies
 - will be converted to Renminbi at the exchange rate quoted by ICBC on the day of conversion. If the amount of Renminbi after conversion from Hong Kong Dollars or other foreign currencies does not cover the total Renminbi outstanding amount in the Renminbi Card Account, the Account Holder and the Cardholder
- to which such amount in Renminbi relate shall remain iointly and severally liable for any difference caused by such currency conversion. 10.3 Hong Kong Dollar Card Account payments:
 - Payments in the Hong Kong Dollar Card Account (which shall include for the avoidance of doubt any Card Transactions within Mainland China which have been converted from Renminbi into Hong Kong Dollars) shall be settled in Hong Kong Dollars at any branches of ICBC (Asia) in Hong Kong or by other means as advised by ICBC (Asia) from time to time. ICBC (Asia) may (exceptionally but without any obligation) accept other foreign currencies acceptable
 - Card Account. In the event of payment in accordance with clause 10.3(b) above, the foreign currencies will be converted into Hong Kong Dollars at the exchange rate quoted by ICBC (Asia) as applicable on the date of conversion. If the amount of Hong Kong Dollars after the conversion

to ICBC (Asia) for payments to the Hong Kong Dollar

- of such foreign currency does not cover the total Hong Kong Dollars outstanding amount in the Hong Kong Dollar Card Account, the Account Holder and the Cardholder to which such amount in Hong Kong Dollars relate shall remain jointly and severally liable for any difference caused by such exchange conversion. 10.4 All payments:-
- shall be deemed not to have been made until such time as the relevant funds have been received in cleared and available funds by a Bank to which such payments shall be payable without any deduction or withholding on account of any other amount whatsoever whether
 - notwithstanding any legal limitation, disability or incapacity of any Person. All payments made to the Card Account shall be applied to repay the Statement Balance in descending order according to the applicable interest rate or in such other way as the Bank (to which such payments relate) thinks fit

by way of set-off, counterclaim or otherwise, and

- 11.3 The Account Holder must examine each Statement and must notify ICBC (Asia) (for itself and/or on behalf of ICBC) in writing within 60 days from the issue date of such Statement of any unauthorised Charges arising from whatever cause,

- including forgery, fraud, lack of authority or negligence of the Account Holder, any Cardholder or any other Person. After such period, the Statement will be deemed to be correct and conclusive evidence of the balance upon the applicable Card Account. No claim to the contrary by the Account Holder or
- any other Cardholder shall be admissible against a Bank unless any such unauthorized Charge arose from any of the following:
- - any unauthorized transactions arising from forgery or fraud by any third party including any employee, agent or servant of the Account Holder and the Cardholder and in relation to which a Bank has failed to exercise reasonable care and skill:
 - - unauthorized transactions arising from forgery or fraud by any employee, agent or servant of a Bank; or other unauthorized transactions arising from the default
- or negligence on the part of a Bank or any of its employees, agents or servants.
 - 11.4 Where the Account Holder or any Cardholder reports an unauthorised transaction before the Payment Due Date, the Account Holder or such Cardholder may give a written
- 10.5 All payments into or credits made to either the Hong Kong

request to ICBC (Asia) (for itself and/or on behalf of ICBC) to withhold the obligation to make payment of the disputed amount during the investigation period by ICBC (Asia) (for itself and/or on behalf of ICBC) and requesting that any finance charges be suspended in respect of the disputed

and/or on behalf of ICBC). If, however, the report made by the Account Holder or such Cardholder is subsequently

proved to be unfounded, each Bank reserves the right to re-impose the finance charges on the disputed amount over the whole period, including the investigation period. The duration of any investigation period shall be at the sole discretion of the Bank to which such unauthorised transaction relates (but shall be no longer than 90 days except in circumstances which are beyond the control of such Bank) and the Account Holder, and such Cardholder and the Account Holder shall follow the instructions of such Bank and fully cooperate with such Bank in relation to any

12. Rights of a Bank

12.1 Nothing in this Agreement shall affect a Bank's right of set-off, transfer and application of monies at law or pursuant to any other agreement from time to time subsisting between a Bank and any Person.

- 12.2 Any credit to be given in respect of Charges will be applied by a Bank to the applicable Card Account only after deduction of any costs (including but not limited to collection and remittance costs), if any, so incurred to such Bank for applying the credit.
- 12.3 ICBC (Asia) is entitled (but not legally obliged):to give effect to any instruction given by any Person to effect payment of sums due under this Agreement from another account with ICBC (Asia);
 - to set-off or transfer, at any time and without prior notice, any monies of whatever description standing in the books of ICBC (Asia) to the credit of the Account Holder, whether held singly or jointly with others and whether in Hong Kong Dollars or any other currency in or towards discharge of the total amount debited to the Hong Kong Dollar Card Account; and
 - to set-off or transfer, at any time and without prior notice, any monies of whatever description standing in the books of ICBC (Asia) to the credit of a Cardholder, whether held singly or jointly with others and whether in Hong Kong Dollars or any other currency in or towards discharge of the total amount of Charges in the Hong Kong Dollar Card Account attributable to his own use of a Card. For the purpose of set-off of funds in any currency other than Hong Kong Dollars, ICBC (Asia) may convert the currency

into Hong Kong Dollars at the prevailing exchange rate determined by IČBC (Asia) at the time of conversion. If ICBC (Asia) exercises its rights under this Clause 12.3(b) and 12.3(c), it shall promptly notify the Account Holder or, as the case may be, the Cardholder to which such exercise of rights relates. 12.4 Any branch of ICBC in Mainland China is entitled (but not

- legally obliged):
 - to set-off or transfer, at any time and without prior notice, any monies of whatever description standing in the books of ICBC to the credit of the Account Holder, whether held singly or jointly with others and whether in Renminbi or not, in or towards discharge of the total amount debited to the Renminbi Card Account; and
 - to set-off or transfer, at any time and without prior notice, any monies of whatever description standing in the books of ICBC to the credit of a Cardholder, whether held singly or jointly with others and whether in Renminbi or not, in or towards discharge of the total amount of

Charges in the Renminbi Card Account attributable to his own use of a Card.

If any branch in ICBC in Mainland China exercises its rights of set-off or transfer under this clause 12.4. ICBC shall promptly notify ICBC (Asia), which shall thereafter promptly notify the Account Holder or, as the case may be, Cardholder (to which such exercise of rights relates) of the same.

Where the Card Account is in credit, the Bank may (but

- is not obliged to), refund to the Cardholder a part or the whole of the credit balance in the Card Account upon request by the Cardholder or at any time that the Bank (in its sole and absolute discretion) chooses. A refund under Clause 12.5(a) will be made upon such
- conditions as the Bank may reasonably impose including the manner in which the refund will be made. 13. Exclusion and Limitation of Liability

13.1 No Bank shall be under any liability whatsoever to the Account

- or withdraw any of the facilities, services or benefits from time to time available in respect of a Card pursuant to Clause 16.3 below, (ii) to amend the credit limit (including but not limited to any cash advance limit or limit on Balance Transfer amount) applicable to a Card or a Card Account pursuant to Clause 16.4 below, or (iii) to terminate a Card or a Card Account pursuant to Clause 17 below;
- any injury to the credit character and reputation of the Account Holder or any Cardholder in connection with or caused by the repossession of a Card, any request for its return or the refusal of any Person to honour or accept a Card whether or not instructed by a Bank;

- any act of fraud, forgery or gross negligence of a Cardholder or any other Person (not being an employee, agent or servant of a Bank), including (without limitation) such Cardholder's failure to observe Clauses 7 and 13.4 or follow any other recommendation of a Bank from time to time regarding the safety and secrecy of a Card and the PIN: or
- any act or omission of any third party (other than agents
- of a Bank) through which facilities of a Cardholder or the Account Holder may be made available provided that such Bank shall have exercised reasonable care and skill in connection with its dealings with such third party.
- 13.2 Provided a Cardholder has not acted fraudulently or with gross negligence, such Cardholder and the Account Holder shall not be liable for loss as incurred:
 - where a Card Transaction instruction effected by a Bank was given by use of a Card before a Cardholder or the Account Holder received a Card, or given through the use of a lost, stolen or counterfeit card after ICBC (Asia) (for itself and/or on behalf of ICBC) has received proper notice of the loss or theft of his Card or that the PIN is or may be known to any other Person from such Cardholder through the Hotline in accordance with Clauses 7.3 or 13.4 (as the case may be) or any other means acceptable to ICBC (Asia) (for itself and/or on behalf of ICBC) (provided that in the case of a lost or

stolen card, such Cardholder has acted in accordance

directly as a result of a fault in any automated teller machines and other facilities which was not obvious or was not advised by a message or notice on display or otherwise drawn to such Cardholder's attention. 13.3 In the event of any proceedings which a Cardholder and/or the Account Holder may bring against a Bank for any cause

- 14.1 The Account Holder and each Cardholder agree:

Agreement:

- that the provisions of the Data Notice shall apply generally to ICBC (Asia)'s (for itself and/or on behalf of ICBC) and ICBC's treatment of their personal data.
- 14.2 Without prejudice to the Data Notice, the Account Holder and each Cardholder authorise a Bank to contact any Person (including, without limitation, employers, banks, financial
- institutions, credit card issuing companies, credit reporting agencies, credit bureaux or any other information sources) to obtain, exchange and disclose credit reports and references and any other information a Bank may require to operate a Card Account. A Bank shall not approach any proposed referee for the Account Holder or the Cardholder unless the Account Holder or that Cardholder has first confirmed that he

may be adverse to the interests of the Account Holder or the

- has obtained the prior consent of such referee. 14.3 The Account Holder and each Cardholder authorise a Bank to compare information provided by the Account Holder and any Cardholder with other information collected about them for checking purposes or to produce more data. A Bank may use the results of such comparisons for the purposes of taking any action in relation to a Card including action which
- Cardholder, for example, denying authorisation for the use of a Card or cancelling a Card.
- 14.4 Subject to the Data Notice, the Account Holder and each Cardholder authorise a Bank to hold, store, use, otherwise process and administer, for the purposes of operating a Card Account, marketing, verification of data, credit checking and enforcing this Agreement, any information about the Account Holder, any Cardholder and the Card Account and to disclose any such information as is necessary for these purposes to:
 - any Persons employed or contracted by a Bank (whether in Hong Kong, Mainland China, or any other part of the world) or branches of ICBC in Mainland China who shall provide such Bank with any services in relation to the administration and production of the Cards including, without limitation, administrative and data processing services in connection with the maintenance and operation of customer accounts, marketing of banking and card services, and card embossing services;
 - other Bank Group Companies worldwide;
 - any Person whose name or logo appears on a Card; (c)
 - any actual or proposed transferee, assignee or successor of all or any part of the assets or business of a Bank, or

- other banks, financial institutions, debt collection agencies, credit and payment card companies, credit reference agencies; and
- governmental or regulatory authorities, whether in Hong Kong or elsewhere, and legal counsel, and to consent to the transfer to, and use of such information in, Hong Kong, Mainland China or such other country as a Bank may reasonably consider appropriate.
- 14.5 The Account Holder and each Cardholder authorise each Bank to disclose such information as is necessary in relation to the Account Holder and any Cardholder to governmental or regulatory authorities, whether in Hong Kong, Mainland China or such other country, in compliance with any laws, regulations or court orders.
- regulations or court orders.

 14.6 ICBC (Asia) (for itself and/or on behalf of ICBC) may from time to time send to the Account Holder and each Cardholder marketing or promotional materials and documents and/or newsletters by whatever means which the Bank may think fit
- (e.g. by mail, email or mobile phone message).14.7 A Cardholder shall have the right to request a Bank to cease using the personal data of such Cardholder for the Bank's marketing purposes without charge to such Cardholder.

14.8 ICBC (Asia) (for itself and/or on behalf of ICBC) agrees to

- notify the Cardholder(s) or the Account Holder (as the case may be) in writing within 30 days of a Cardholder's or the Account Holder's default in payment of at least the Minimum Payment on the Payment Due Date. Unless the Minimum Payment is fully repaid before the expiry of 60 days from the Payment Due Date, such Cardholder or the Account Holder (as the case may be) shall be liable to have his account data retained by credit reference agencies until the expiry of
- data retained by credit reference agencies until the expiry of 5 years from the date of final settlement of the amount in default or 5 years from the date of such Cardholder's or the Account Holder's discharge from bankruptcy (as the case may be)as notified to the credit reference agencies, whichever is earlier.

 15. Transfer, Assignment and Sub-Contracting

15.1 For the avoidance of doubt, a Bank may at any time transfer,

- assign, delegate or sub-contract any or all of its right or obligations under this Agreement to any Person without prior notice to the Account Holder or any Cardholder.
 Amendment
 16.1 This Agreement and any fees, charges and interest and charge.
- 16.1 This Agreement and any fees, charges and interest and charge rates payable or applicable under this Agreement may be amended from time to time by ICBC (Asia) (for itself and/or on behalf of ICBC). ICBC (Asia) (for itself and/or on behalf of ICBC) will give prior notice to the Account Holder and the Cardholders in a manner ICBC (Asia) considers appropriate.
- 16.2 If the Account Holder or the Cardholder does not accept such amendment, he shall give written notice to ICBC (Asia) (for itself and/or on behalf of ICBC) before the effective date of the amendment, terminating the use of a Card and, if appropriate, the Card Account and returning his Card to ICBC (Asia) (for itself and/or on behalf of ICBC) cut in two or otherwise defaced. Any debit balance on the Card Accounts shall also be paid in full at that time. If the Account Holder or the Cardholder uses his Card or retains a Card after the effective date of an amendment, the Account Holder and
- amendment in all respects without reservation.
 16.3 Subject to Clause 16.1 above, a Bank may add to, reduce, modify, suspend or withdraw any of the facilities, services or benefits from time to time available in respect of a Card without notice.
 16.4 A Bank may at any time amend the credit limit (including but

- 16.5 ICBC (Asia) (for itself and/or on behalf of ICBC) may give notice of any amendment referred to in this Clause 16 (except Clauses 16.3 and 16.4 above) in writing, in the Statements or by display at its branches, press advertisement or otherwise, stipulating a date on which such amendment shall take effect.

17. Termination

- 17.1 (a) The Account Holder may at any time by giving reasonable notice in writing to ICBC (Asia) (for itself and/or on behalf of ICBC) or by such other method as ICBC (Asia) may deem appropriate terminate both
 - ICBC (Asia) may deem appropriate terminate both Card Accounts.

 (b) Subject to Clause 17.1(c) below, such notice will not take effect until such written notice and all Cards
 - (including any supplementary Cards), duly cut in two or otherwise defaced, have been received by ICBC (Asia).
 In relation to any supplementary Card issued to a Cardholder, the Account Holder shall remain liable for the use of such Card until it is returned to ICBC (Asia) (for itself and/or on behalf of ICBC), or ICBC (for itself
 - promptly, is able to implement the procedures which apply to lost Card if the Account Holder so requests.

 d) The Account Holder agrees that he may be liable for any costs and expenses arising from ICBC (Asia) (for itself and/or on behalf of ICBC) implementing the procedures applying to lost Cards pursuant to Clause 17.1(c) above.

and/or on behalf of ICBC (Asia)), which shall act

- (e) A Cardholder may also request cancellation of his Card by notice to ICBC (Asia) accompanied by return of a Card. For the avoidance of doubt, supplementary Cards may be terminated by either the Account Holder or such supplementary Cardholder by giving reasonable written notice to ICBC (Asia) (for itself and/or on behalf of ICBC) accompanied by the return of the Card, duly cut in two or otherwise defaced.
- (f) For the avoidance of doubt, the Hong Kong Dollar Card Account shall be deemed to be terminated upon termination of the Renminbi Card Account, and vice versa.
- (g) A Cardholder's right to use a Card shall be terminated upon termination of this Agreement pursuant to this Clause 17.
- Clause 17.

 17.2 A Bank may at any time, with or without notice as such Bank may determine in the circumstances, terminate the Card Account (to which such Bank relates) or a Card without giving any reasons. For the avoidance of doubt, these would
- include when ICBC (Asia) is informed by a Cardholder that his PIN is or may be known to any other Person.

 17.3 On termination of the Card Accounts (and notwithstanding any prior agreement between a Bank and the Account Holder or any Cardholder to the contrary) or on the death or bankruptcy of an Account Holder the total sum due to a Bank as reflected in a Card Account, and the amount of any Charges incurred after termination, shall become immediately due and payable by the Account Holder and.
 - as the case may be, every Cardholder. Interest will accrue thereon thereafter at such rate as ICBC (Asia) may from time to time notify to the Account Holder and such Cardholder. The Account Holder and the Cardholder shall be jointly and severally responsible for all outstanding Charges together with interest under a Card Account notwithstanding the termination of this Agreement.
- 18. Automated Teller Machines, Bank Account Services and Other Facilities
- 18.1 If a facility has been incorporated into a Card to enable such

Card to be used in automated teller machines, point of sale terminals and other computer terminals or otherwise to carry out electronic transactions, the use of such facility shall also be governed by the specific terms and conditions issued by ICBC (Asia) (for itself and/or on behalf of ICBC) relating to that facility from time to time in force.

- 18.2 If a facility has been incorporated into a Card to enable such Card to be used to access a Cardholder's bank account with ICBC (Asia), the terms and conditions of ICBC (Asia) governing such bank account from time to time in force shall apply to the use of a Card for these purposes.
- 18.3 If ICBC (Asia) introduces any other products, facilities or services to Cardholders through a Card, the same shall also be governed by their own specific terms and conditions from time to time in force.
- 18.4 If there shall be any conflict between any specific terms and conditions governing the automated teller machine facility and any other products, facilities or services introduced by ICBC (Asia) and this Agreement, the specific terms and conditions of each product, facility or service shall prevail.

10 Notices

- 19.1 Each Cardholder (other than the Account Holder) irrevocably appoints the Account Holder as his agent for the purposes of service by a Bank of:-
 - the Statement, including any notice (whether on the front or the reverse of the Statement) for which provision is made pursuant to this Agreement;
 - (b) any other demand, communication or notice made or given by a Bank pursuant to this Agreement; and
 - (c) legal process.
- 19.2 Any of the documents referred to in Clause 19.1 above may be served by sending or making available the same (i) by ordinary post to the usual or last known address of the Account Holder, or (ii) by fax, email or otherwise over the internet and such document shall be deemed to have been duly served (a) two days after the date of posting or transmission if mailed to an address in Hong Kong or sent or made available by fax, email or otherwise over the internet or (b) seven days after posting if mailed to an address elsewhere, save that in the case of legal process these periods shall be increased to seven and twenty-one days respectively and relevant documents may not be served by fax, email or over the internet unless permitted by law.
- 19.3 The Bank is not responsible for the Account Holder's or the Cardholder's failure to receive a statement or other communication if the Bank send it to the usual or last known address, or in accordance with other contact information for the account appearing in the Bank's record. The Bank is authorized to withhold statement or other communication by post if previous mail to Account Holder's usual or last known address is returned for non-delivery due to address change and the Account Holder cannot be contact. For mutual protection, the Account Holder must advise the Bank immediately of any address change or other information to keep the Bank's records current.
- 19.4 (a) Notwithstanding anything contained in this Agreement, each Bank is requested and authorised to act in accordance with and rely on any instruction or other notice or communication which may be or purport to be given or made available by telephone, fax or email or otherwise over the internet.
 - (b) Subject to Clause 19.4(c) below, ICBC (Asia) (for itself and/or on behalf of ICBC) may (but shall not be obliged to) act on any notice which ICBC (Asia) (for itself and/or on behalf of ICBC) in good faith reasonably believes to be genuine and to have emanated from the Account Holder or any Cardholder (as the case may be).

- c) ICBC (Asia) (for itself and/or on behalf of ICBC) may (but shall not be obliged to) verify the identity or authority of the Person giving or purporting to give the notice or as to the authenticity of any notice given by telephone, fax or email or otherwise over the internet and without requiring further confirmation in any form.
- (d) Each Cardholder and the Account Holder undertakes to keep a Bank indemnified against all reasonable claims, demands, actions, proceedings, damages, losses, costs and expenses including all legal fees and disbursements brought against or reasonably incurred by such Bank and arising out of anything done or omitted pursuant to any telephone, fax or email or other internet notice received by such Bank, save in the case of such Bank's fraud or nedligence.
- e) ICBC (Asia) (for itself and/or on behalf of ICBC) may at its discretion (but shall not be obliged) to record notices given by telephone, in writing and/or any other method determined by ICBC (Asia) (for itself and/or on behalf of ICBC). ICBC (Asia)'s (for itself and/or on behalf of ICBC) record of any such notice shall be conclusive and binding on the Account Holder or the Cardholder in whose name the notice was given in the absence of manifest error, fraud or negligence. ICBC (Asia) (for itself and/or on behalf of ICBC) may also require such Cardholder to confirm in writing any instructions given by telephone.
- 19.5 Copies of the Agreement and Fee Schedule for the time being in force are available at all branches of the Bank and in the Bank's website at www.icbcasia.com.

20. Expenses of Enforcement

20.1 The Account Holder and, as the case may be, every Cardholder shall indemnify a Bank in respect of any and all reasonable expenses properly incurred by a Bank in enforcing or attempting to enforce this Agreement including all reasonable legal fees, charges of debt collection agencies and disbursements. ICBC (Asia) shall, on request, provide the Account Holder and, as the case may be, every Cardholder with a breakdown of all expenses he is liable to pay under this Clause 20.

21. Third Party Rights Exclusion

Any person or entity that is not a party to these this Agreement shall have no rights under the Contracts (Rights of Third Parties) Ordinance (Cap. 623) to enforce any part of this Agreement.

22. Law and Language

- 22.1 The Agreement shall be construed and the provision of Card facilities shall be governed by Hong Kong law, and subject to the non-exclusive jurisdiction of the Hong Kong courts.
- 22.2 If, at any time, any of these terms and conditions are or become illegal, invalid or unenforceable in any respect, the legality, validity and enforceability of the remaining terms and conditions shall not be affected.
- 22.3 Nothing in this Agreement shall operate so as to exclude or restrict any liability of any party to this Agreement, to the extent that such exclusion or restriction is prohibited by the laws of Hong Kong.
- 22.4 If there is any difference between the English language version of this Agreement and the Chinese language version, the English language version shall prevail for all purposes.
