Other ICBC Credit Cards:

Retail Purchase HKD1 = 1 point. All accumulated points are valid for at least 1 year.
Points earned by Principal Card and Supplementary Card(s) can be combined.

Terms & Conditions for Bonus Points Rewards

1. Only principle cardholders of ICBC personal cards or ICBC affinity cards (including but not limited to Hong Kong Dollars ("HKD") and Dual Currency credit cards)(collectively "ICBC Credit Cards") issued by Industrial and Commercial Bank of China (Asia) Limited (the "Bank") are eligible to participate in this Bonus Points Rewards Program (the "Program").
2. The Program is not applicable to Corporate Card.
3. Acceptance of application for redemption of services/mileage/ cash rebate under the Program (the "Rewards") is subject to the account(s) under which the redemption is stated to be made being (i.e. up to the date of the application of the Rewards as determined by the date of the postmark of the application) in normal/current status (i.e. not overdue or in collection or cancelled or expired) and there having been no breach by the principal cardholder and the supplementary cardholder of the ICBC Credit Card of any of his/her obligations under the applicable cardholder agreement. All the Rewards are subject to availability and application for the Rewards shall be entertained on a first-come-first-served basis, while stocks last.
4. Provided that the Principal Cardholder has accumulated sufficient and valid Bonus Points (the "Points"), and subject to clause 4 below, there is no limit to the number of Rewards that each Principal Cardholder is entitled to redeem at any one time.
5. Subject to clause 4 below, only the Principal Cardholder is entitled to draw upon the Points accumulated in his or her related Principal or Supplementary ICBC Credit Card Account (the "Card Account"). Supplementary Cardholder is not entitled to redeem the Points.
6. Upon acceptance of the application, the Points shall be deducted from the Card Account specified by the Principal Cardholder. If it is discovered that the designated Card Account does not contain sufficient number of the Points for deduction, the Principal Cardholder shall not be entitled to the related Rewards he/she has applied for, notwithstanding his/her application may have been accepted by the Bank. Acceptance of the application is also subject to clause 1 above. The Principal Cardholder will be notified by mail if his/her application is invalidated and/or rejected.
7. One Point will be awarded for every 1 HKD or every 1 RMB spent on Dual Currency credit card while one Point will be awarded for every 1 HKD spent on other ICBC Credit Cards by the Principal Cardholder.
8. Bonus point is not applicable to cash advances, balance transfer, cash installment loan amount/ tax loan and personal loan amount/ merchant installment loan amount and the repayment amount, reload/ transfer of e-wallet (including but not limited to Alipay, PayMe, Tap & Go and WeChat Pay), donations, purchase of casino chips, gambling transactions, unauthorized transactions, all payment type (including but not limited to credit card charges, cash installment, any financial charges, overdue charges, all account service charges, settlement through online personal banking service or ATM for insurance payment or utilities bills, tax payment, payment for MPF contribution etc. Or other categories as we may at our sole discretion determine from time to time). Also, the Rewards are not applicable to the transactions of supermarkets, fuel, transportation fees, property, motor vehicle, wholesale, hospital and tuition in China etc. (transaction types are determined according to the merchant categories as defined from time to time by Visa, MasterCard and UnionPay and reserves the right to change the merchant categories from time to time, or at its sole discretion of Industrial and Commercial Bank of China and (Asia) Limited). Transactions which have not been posted, cancelled, refunded or not authorized are not eligible to the rewards.
9. The Bank reserves the rights to change the Points earning rate. The Points earned by the Supplementary ICBC Credit Card will automatically accrue to its respective Principal Card Account. The Points awarded from HKD account and RMB account in Dual Currency credit card will be pooled together for redemption purpose.

- If the Principal Cardholder has more than 1 Principal Card Account, the Points in each principal Card Account cannot be pooled together for redemption. For cancellation of any card transaction arising from returned goods or services or from billing disputes, the relevant Points awarded from such card transaction will be deducted from the Card Account accordingly. For the Principal Cardholders enjoying the cash rebate in the Program, all cash rebate earned are only meant for future retail spending and cannot be used to offset any cash advance, financial charge or outstanding balance incurred before.
10. The Points earned for Gold Card and Classic Card will be valid for 12 months while the Points earned for the other cards including UnionPay Dual Currency Diamond Card, Visa Signature Card and Platinum Card etc. will be valid for 36 months. The applicable expiry date will be clearly shown on the monthly Card Account statement. After the applicable expiry date, all accumulated expired Points shall be forfeited without further notice.
 11. Once a redemption application has been accepted by the Bank, no cancellation, or alteration of such application can be made by the Principal Cardholder. A redemption letter will be sent to the Principal Cardholder within 4 to 6 weeks after the redemption application is accepted. If a Principal Cardholder does not receive a notification within 6 weeks, he or she should inquire through our 24-hour Customer Service Hotline.
 12. All the Rewards should be collected within 1 month from the issue date of the redemption letter. Otherwise, the relevant Principal Cardholder will be deemed to have given up the Rewards and the Points used for the redemption will not be refunded.
 13. All the Rewards are to be collected by Principal Cardholder in person at the designated redemption centre upon presentation of the original redemption letter issued by the Bank and the Principal Cardholder's current valid ICBC Credit Card. The Principal Cardholder may authorize a person to collect the redemption item(s) on his/her behalf provided that the authorized person presents his/her HKID card, the Principal Cardholder's original redemption letter issued by the Bank, an authorization letter, a written and signed (the signature should be the same as that set out on the Credit Card of the Principal Cardholder) authorization from the Principal Cardholder stating the name and the HKID Card number of the designated person, and a copy of both sides of the relevant ICBC Credit Card(s).
 14. To redeem for the mileage, the Principal Cardholder must be a member of respective airlines' mileage program.
 15. Regarding the mileage redemption of Air China PhoenixMiles, every 8 Points is equivalent to 1 mile. For every redemption, a minimum of 500 miles (i.e. 4,000 Points) or its multiple is required, except Air China requires a minimum of 1,000 miles upon first redemption. Regarding the mileage redemption of Hong Kong Airlines Fortune Wings Club Miles, every 10 Points is equivalent to 1 mile. For every redemption, a minimum of 500 miles (i.e. 5,000 Points) or its multiple is required. The Bank reserves the right to change the mileage earning rate. Once converted, the mileage cannot be converted back.
 16. The Bank has no liability on the mileage redeemed and any changes or actions taken by respective airlines in relation thereto.
 17. Upon the conversion of the Points to mileage, no alteration and cancellation can be made. 4 to 6 weeks are required for mileage redemption. Mileage will be credited to Principal Cardholder's mileage program membership account by respective airlines directly.
 18. Mileage redemption shall be further subject to the terms and conditions of airlines. In case of disputes, the decision of respective airlines shall be final.
 19. Fraud and abuse relating to the earning of the Points in the Program or redemption of Rewards may result in the cancellation of the accrued Points as well as the cancellation of a Principal Cardholder's entitlement to the Program. The Bank reserves the rights to take legal action in such cases and to recover (among others) the Rewards.
 20. The Bank is not the supplier of any of the Rewards offered to the Principal Cardholder, and will not accept any liability in relation thereto. All representations and warranties relating to quality, design, specification or otherwise set out in this Bonus Points Rewards Catalogue in respect of such Rewards are made by the respective suppliers/merchants and the use of the Rewards will be bound by the terms and conditions of the respective suppliers/merchants. The Bank is not responsible for any loss or theft of the redemption letter.

 22. The Bank has made every effort to ensure all information in this Bonus Points Rewards Catalogue is accurate. However, the Bank accepts no responsibility for any error or omission contained therein. The Bank reserves the right to make the final decision if there is any error or omission.
 23. All the Rewards featured in this Bonus Points Rewards Catalogue are valid until December 31, 2023 (unless specified otherwise).
 24. The Rewards shall be terminated immediately upon cessation of the relevant merchant's business.
 25. The Bank reserves the right to vary the Program and/or these Terms and Conditions, or to cancel the Program at our discretion at any time without giving you prior notice.
 26. In case of any dispute arising from the Program, the decision of the Bank shall be final.
