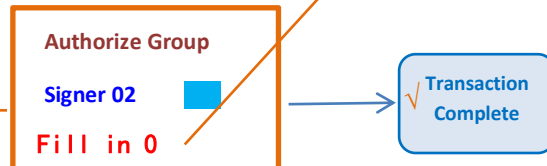

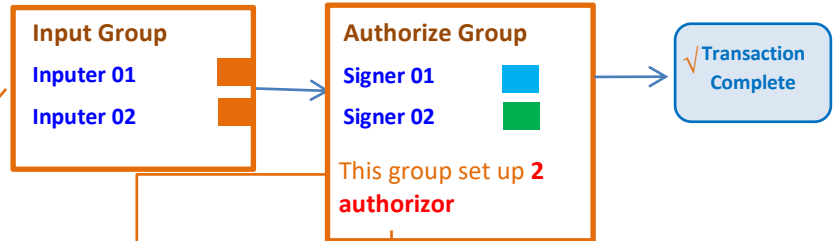

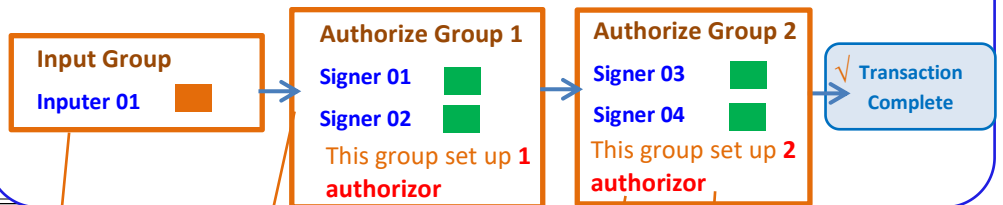

4C Example 1-Financial Transaction-After input, 2 Authorize Groups doing ordered



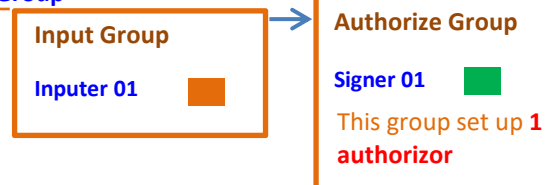
