

網上遞交申請禮品之條款及細則

- 1. 信用卡免找數簽賬額 (「網上遞交申請禮品」) 只適用於即日至 2019 年 12 月 31 日·包括首尾兩天,成功透過中國工商銀行(亞洲)有限公司(「本行」)網站申請及獲批核指定信用卡的全新主卡申請人。如申請人現在為本行信用卡客戶或於過往 6 個月內取消任何本行信用卡(包括聯營卡)、即不可獲享網上遞交申請禮品。
- 2. 申請人經網上成功申請本行指定信用卡及獲批核後,每張信用卡將合資格獲取 HK\$50 信用卡免找數 簽賬額。
- 3. 本行信用卡中心將於 6 至 8 星期後將信用卡免找數簽賬額存入有關信用卡賬戶內·信用卡免找數簽賬額只可作日後簽賬,不可用作現金透支或繳付信用卡結欠。
