: (1) The injury received or the death occurred while riding as a passenger, and not as a pilot or crew member, on or boarding or alighting from or being struck by an air, land or water public conveyance operated under a licence for the transportation of passengers for hire.

- (2) In respect of such trip by air, such injury received or the death occurred while riding as a passenger in a private registered four-wheeled motorized vehicle or public conveyance operated under a licence for the transportation of passengers for hire, but only:
  - (a) When going directly to an airport for the purpose of boarding an airworthy, licensed and schedule common carrier aircraft operated by airline on which the insured person is covered by the policy, or
  - (b) When at the airport terminal itself, or
  - (c) When leaving directly from an airport after alighting from such aircraft until they reach their next destination
- (3) Insurance cover will also be offered for any public conveyance tickets embedded in the travel package provided that not less than 50% fare for such travel package has been charged by the cardholder to his card account

No cover for insured person whose passenger fare is paid through built-in Octopus Automatic Add Value Service.
