Event : (1) The injury received, or the death occurred while riding as a passenger, and not as a pilot or crew member, on or boarding or alighting from or being struck by an air, land or water public conveyance operated under a licence for the transportation of passengers for hire.
 (2) In respect of such trip by air, such injury received, or the death occurred while riding as a passenger in a private registered four-wheeled motorized vehicle or public conveyance operated under a licence for the transportation of passengers for hire, but only:
 (a) When going directly to an airport for the purpose of boarding an airworthy, licensed and scheduled common carrier aircraft operated by airline on which the insured person is covered by the policy, or
 (b) When at the airport terminal, or cruise terminal itself, or
 (c) When leaving directly from an airport after alighting from such aircraft until they reach their next destination
 (3) Insurance cover will also be offered for any public conveyance tickets embedded in the travel package provided that not less than 50% fare for such travel package has been charged by the cardholder to his card account

Condition : Not less than 50% of public conveyance fare for the cardholder has been charged to the designated Corporate Card &/or Personal Visa Signature card's account with ICBC (Asia). No cover for insured person whose passenger fare is paid through built-in Octopus Automatic Add Value Service

- 保障概要** : (1) 卡持有人以乘客身份(不可以為駕駛員或航倉服務員), 上落或乘坐有關以【指定卡】付費之合法經營載客公共交通工具上, 意外引致身體傷害。
(2) 以乘坐飛機作旅程, 而受傷或死亡由乘坐私人登記四輪機動車輛或合法經營載客公共交通工具引致, 而該意外只適合以下情況:
(a) 當直接前往機場而目的是進行登機, 而該航機亦是預定合法經營載客公共交通工具, 符合航空安全及由合規航空營運者主理, 或
(b) 機場管轄範圍內, 或
(c) 當直接離開飛機前往下一目的地途中
