

ICBC Asset Management (Global) Funds – ICBC Asset Management Asia Selection Growth Fund

- The ICBC Asset Management Asia Selection Growth Fund (the "Sub-Fund") may invest primarily in certain industries or geographical regions. To the extent that an industry or a geographical region in which the Sub-Fund invests fall out of favor, the Sub-Fund's performance may be negatively affected.

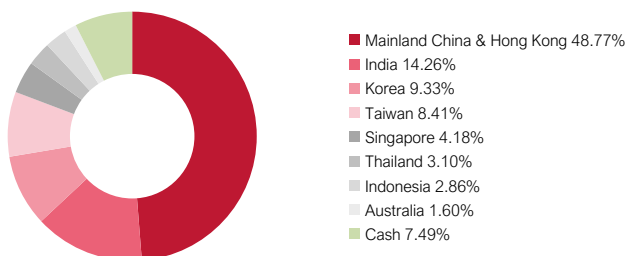

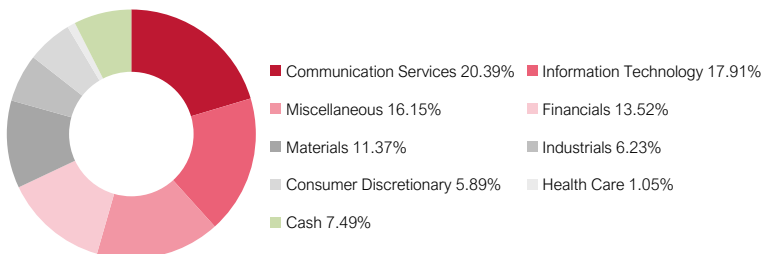

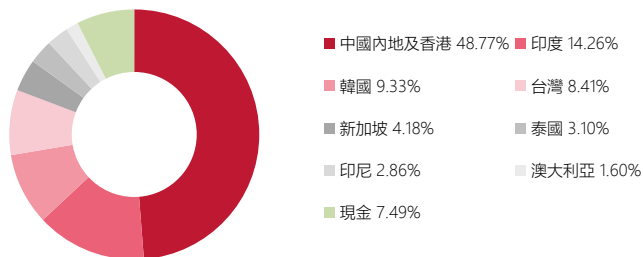

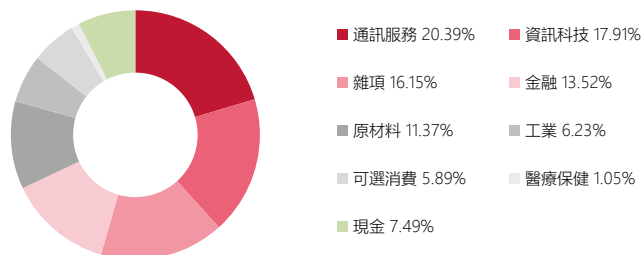
