Average Liquidity Maintenance Ratio (LMR) is disclosed in accordance with Sections 103B of the Banking (Disclosure) Rules. The average values are the arithmetic mean of the average LMR for each calendar month in the reporting period. The average LMR is reported in the Return of Liquidity Position submitted to the HKMA pursuant to Section 63 of the Banking Ordiance.

160.03% for 31 March 2019 is the average of the ratios from January to March 2019 which are prepared according to the liquidity maintenance ratio methodology as stipulated in the completion instructions issued in January 2015 (31 December 2018: 160.03% is the average of the ratios from October to December 2018).
