Fee per transaction regardless of remittance amount.

The inward credit fee is charged regardless of field 71A (SHA/BEN/OUR) on SWIFT message.

For FCDU charges, if paid in third currency, equivalent in USD charges.

Incidental costs such as postage, courier, cable, notarial fee and out-of-pocket expenses as well as correspondents' charges, if any, will be added thereon.

Any notice of change of fees and commissions may be posted in the Bank's website and/or its premises as the Bank may consider to be more effective and relevant.
