

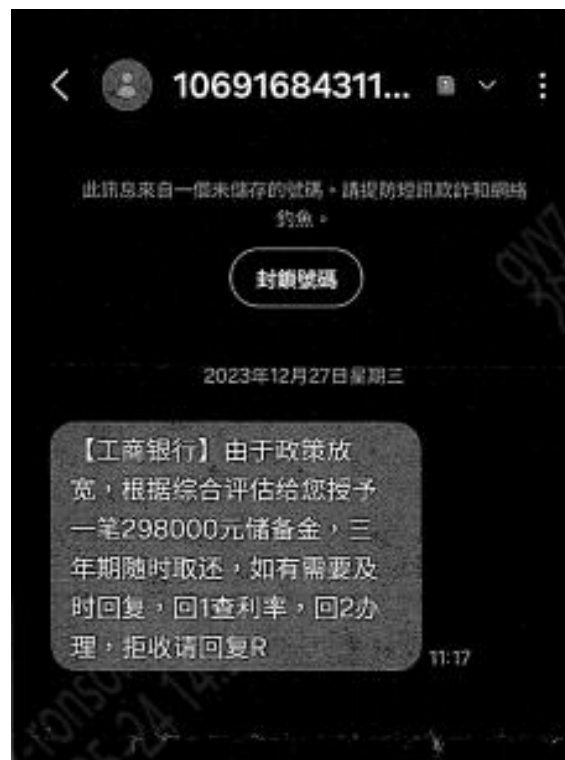
Fraudulent SMS Message Alert

27 May 2024, Hong Kong – Industrial and Commercial Bank of China (Asia) Limited (“ICBC (Asia)” or “the Bank”) would like to alert all customers and the public that the Bank noticed a fraudulent SMS message (please refer to the screenshot). The Bank would like to alert all customers and the public, and declare that the Bank and Industrial and Commercial Bank of China Limited have no connection with the SMS message. The Bank would also like to remind all customers and the public to stay vigilant and not to provide any personal data through such SMS message.

The Bank has reported the above case to the Hong Kong Police Force, and will report to the Hong Kong Monetary Authority and take necessary and appropriate action to protect the reputation of the Bank and the interests of its customers and the public. Anyone who has provided personal information through such fraudulent SMS message should report to the Hong Kong Police Force immediately for investigation.
