



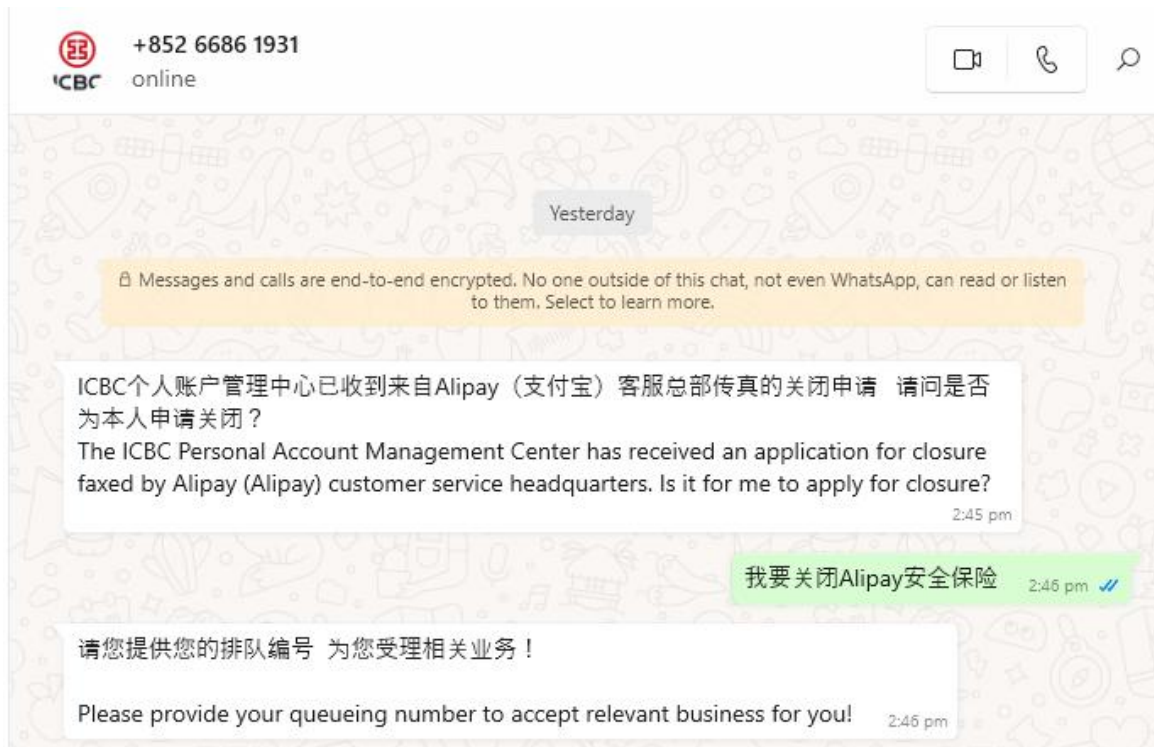
Fraudulent Messages

24 February 2025, Hong Kong – Industrial and Commercial Bank of China (Asia) Limited (“ICBC (Asia)”) would like to alert all customers and the public that the Bank noticed fraudulent messages through the instant messaging application WhatsApp (shown in the screenshot) from culprits pretending to be a staff member of Industrial and Commercial Bank of China (ICBC) contacted the public, and falsely claimed to assist them to handle insurance related business of Alipay, which involved phone number “+852 6686-1931”. The Bank would like to alert all customers and the public that ICBC (Asia) and ICBC have no connection with the aforesaid phone number and messages, and also remind all customers and the public to stay vigilant and not to provide any personal data through such phone number and messages.

The Bank has reported the above case to the Hong Kong Police Force and the Hong Kong Monetary Authority, and will take necessary and appropriate action to protect the reputation of the Bank and the interests of its customers and the public. Anyone who has provided personal information through such fraudulent phone number and messages should report to the Hong Kong Police Force immediately for investigation.
