7 March 2025, Hong Kong – Industrial and Commercial Bank of China (Asia) Limited ("ICBC (Asia)") would like to alert all customers and the public to phishing websites purported to be from ICBC (Asia) (refer to the following URLs and screenshot). ICBC (Asia) declares no connection with such fraudulent websites, and its official website should be "www.icbcasia.com". The Bank reminds all customers and the public to stay vigilant and not to provide any personal data through such fraudulent websites.


