本集團按照澳門金融管理局的規定,當本集團監管儲備所要求的減值準備高於客戶貸款及墊款以及財務保函合約的減值準備金餘額時,本集團將留存收益轉入監管儲備。截止2025年6月30日:監管儲備餘額為461,000,000澳門元(2024年6月30日:616,000,000澳門元),根據澳門金融管理局規定乃不可分配。監管儲備轉為留存收益乃因該等期間監管儲備所要求的金額減少。

Note 1:

The Group complies with AMCM requirement to maintain regulatory reserve in excess of the Group's impairment allowance for loans and advances to customers and financial guarantee contracts estimated through the transfer of retained profits to regulatory reserve. As at 30 June 2025, an amount of MOP461,000,000 (30 June 2024: MOP616,000,000) in regulatory reserve is not distributable under AMCM's requirement. The transfers from regulatory reserve to retained profits were due to the decrease in required regulatory reserve in both period.
