# Important Note

Pursuant to Paragraph 4 of Schedule 9 of the Financial Services Act 2013, if you are applying for this Insurance for a purpose related to your trade, business or profession, you have a duty to disclose any matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied and any matter a reasonable person in the circumstances could be expected to know to be relevant, otherwise it may result in avoidance of your contract of insurance, refusal or reduction of your claim(s), change of terms or termination of your contract of insurance.

The above duty of disclosure shall continue until the time your contract of insurance is entered into, varied or renewed with us

You also have a duty to tell us immediately if at any time after your contract of insurance has been entered into, varied or renewed with us any of the information given in the Proposal Form (or when you applied for this insurance) is inaccurate or has changed.

You are obligated to disclose any relevant matter with the exception of either such disclosure diminishes the risk to us, is of common knowledge, is within our knowledge and/or in the ordinary course of our business or we have waived the disclosure.

In the event you failed to provide relevant and/or complete answer in the proposal form or when you had been requested by us and the matter was not pursued by us, you are deemed to have been waived by us from disclosing any further.

#### 3. How much premium do I have to pay?

This is an annual policy. The premium charges are based on the package premium according to the plan chosen by insured

#### 4. What are the fees and charges I have to pay?

- i. Service Tax
- ii. Stamp Duty to legalise the contract RM10.00
- iii. Agent commission (if any) of 15% (applicable to Section A to D) is included in your policy when there is an intermediary involved.

#### 5. What are some of the key terms and conditions that I should be aware of?

- Importance of Disclosure You must disclose all material facts that you know or ought to know; otherwise your policy may be invalidated.
- You should take all reasonable precautions to prevent theft incidents
- Excess, being the amount, you have to bear before we indemnify you
- Premium Warranty The premium due must be paid and received by the insurer within sixty (60) days from the inception date of this policy/endorsement/renewal certificate.
- Failure to pay the premium within this period, the contract is automatically cancelled, and Generali is entitled to the pro rata premium on the period you have been on risk.
- You must inform Generali in writing on any material changes during the policy period so that the necessary amendments are endorsed to your policy
- Claims: Upon the happening of an accident which gives rise to a claim, you shall notify us immediately

#### 6. What are the major exclusions under this policy?

- Loss or damage directly or indirectly caused by or arising from or in consequence of or controlled by nuclear weapons material
- Earthquake, volcanic eruption or other convulsion of nature
- Typhoon, hurricane, tornado, cyclone or other atmospheric disturbances
- War, Civil War and any act of Terrorism
- Radioactive and nuclear energy risks
- Date recognition
- Property Damage to data or software

#### 7. Can I cancel my policy?

You may cancel your policy by giving written notice to us. Upon cancellation, you are entitled to a refund of pro rata proportion of the annual premium. No refund premium is allowed if there is a claim under the policy.
