Yue Hwa established in 1993 in Singapore after acquiring the building formally known as the Great Southern Hotel. Back in the early days, the building was also better known as the Nam Tin Hotel in Chinatown. Renamed Yue Hwa Building, it was converted into a department store which opened on 9

October 1996. The facade was retained as it was gazetted by URA for conservation. For its conservation and restoration work, Yue Hwa Building won URA's Architectural Heritage Award in 1997.
