

Terms and Conditions governing ICBC Credit Card(s) Exclusive Festive Spend & Get Promotion (“Promotion”)

1. Promotion Period:

This Promotion is valid from 1 December 2024 till 31 January 2025 (both dates inclusive).

2. Promotion Details:

During the Promotion Period, cardholders (by invitation only) who charged a minimum of S\$500 each month to their ICBC Credit Card(s) (combined across multiple ICBC Credit Cards, if applicable) and be eligible for the below gifts. Note: These rewards are stackable.

Please note that the min. spend excludes any transactions that falls under Clause 5.

3. Qualifying Credit Cards (“Qualifying Card(s)”):

All ICBC Singapore Credit Cards

4. Eligibility Criteria:

This Promotion is open to ICBC Credit Card Cardmembers of ICBC Singapore who satisfy the eligibility criterias below (“**Eligible Cardmembers**”):

- a) this promotion is applicable to ICBC Credit Card Cardholders who received an invitation SMS/EDM “Exclusive Festive Spend & Get Promotion” from ICBC. Please note that the promotion is not transferable. However, qualifying transactions charged under the supplementary card will be taken into account for this promotion;
- b) you have made a minimum spend of S\$500 on Qualifying Transactions each month within the Promotion Period; and
- c) your Card account is active and in good standing with ICBC Bank from the start of Promotion Period until point of fulfilment.

5. Qualifying Transactions (“Qualifying Transaction(s)”):

Qualifying Transaction excludes the following transactions:

- a) all cash advances, fees and charges;
- b) annual fees, interests, late payment fees and charges, goods and services taxes or any other fees and charges incurred as a result of using the Card;

- d) any payment to securities brokers or dealers, or any trading or forex related transactions;
- e) any payment of insurance premiums;
- f) any real estate related transactions;
- g) school fees or any other education related fee transactions;
- h) any AXS transactions;
- i) any tax payments;
- j) any transaction subsequently cancelled, void or reversed;
- k) any payment for any outstanding balance owing on the Credit Card account from previous and/or other months;
- l) any POI funding transactions;
- m) any disputed transactions;
- n) any tax refunds credited into the Card account (including supplementary Card account);
- o) any payment made with the following Merchant Category Code (“MCC”); and

Scenario B:	<p>Invited Customer B (has an ICBC UnionPay/Visa Credit Card)</p> <p>Spend S\$500 on his/her ICBC Credit Cards each month and is one of the first 100 cardholders</p> <p>Gifts eligible: S\$20 Cashback</p> <p>Customer B can apply for ICBC Mastercard credit cards to enjoy 20% Cashback on “Bus/MRT” transactions from 1 Feb to 30 Jun 2025</p>
Scenario C:	<p>Invited Customer C: (has an ICBC Mastercard and UnionPay/Visa Credit Card)</p> <p>Spend S\$500 on his/her ICBC Credit Cards each month and is not one of the first 100 cardholders</p> <p>Gifts eligible: 20% Cashback on “Bus/MRT” transactions from 1 Feb to 30 Jun 2025</p>

7. ICBC Singapore Terms and Conditions:

7.1 By participating in this Promotion, you agree to the terms and conditions set out below (including any amendments to the terms after this).

7.2 The Promotion is valid during the Promotion Period.

7.3 Eligible Cardmembers who qualify to receive the Gifts will be notified within sixty (60) working days after the end of the Promotion Period.

7.4 The Gift is neither transferable nor exchangeable for cash, credits, other gifts or otherwise refundable in part or in full.

7.5 Qualifying transactions shall refer to retail transactions, online transactions and foreign currency transactions charged to the Card and posted during the Promotion Period. For the avoidance of doubt, if transaction was made on 31 January 2025 and posted on 1 February 2025, this transaction would not be considered as qualifying transaction under this Promotion.

7.6 Foreign currency transaction which is denominated in a currency other than Singapore Dollars shall be converted into Singapore Dollars based on the Bank’s prevailing foreign currency exchange rates.

7.7 In the event that an Eligible Cardmember qualifies for more than one (1) promotion, the Prize shall be determined by ICBC Singapore accordingly at its absolute discretion.

7.8 You will not be eligible for this Promotion if at the time of fulfillment:

a) your Qualifying Card is not in good standing and is overdue;

- b) your Qualifying Card has been reported lost or stolen;

- e) you violated the terms of your ICBC Credit Card Cardmember's Agreement; or

7.9 We shall reserve the right to disqualify Eligible Cardmembers from this Promotion if the Qualifying Card is no longer in good standing, or in circumstances otherwise determined by us as not eligible for the Promotion.

7.10 We shall not be liable for any failure or delay in the transmission of the transactions by any party including but not limited to merchant establishments. We shall not be liable for any late posting of the transactions thereby affecting your eligibility for this Promotion.

7.11 We shall not accept any liability in relation to the Prize offered under this Promotion. 7.16 These Terms and Conditions are to be read together with our prevailing ICBC Credit Card Cardmember's Agreement ("**Cardmember's Agreement**") (and may be subject to changes from time to time). In the event of inconsistencies between these terms and other terms, these terms shall prevail only to the extent of such inconsistency.

7.17 These Terms and Conditions are governed by Singapore law and by participating in this Promotion, you agree to submit to the exclusive jurisdiction of the Singapore courts. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.

7.18 Our decision in all matters arising from this Promotion is final, conclusive, and binding on all participating cardmembers.

7.19 The promotional materials for this Promotion may be prepared in English and Chinese; in the event of inconsistency, the English version shall prevail.
