

Terms and Conditions governing ICBC Credit Card Activate and Spend: Be rewarded with additional S\$10 cashback campaign (“Promotion”)

Promotion Period:

This Promotion is valid from now till 30 June 2024.

Promotion:

Eligible Cardmembers who activate their qualifying card and spend a minimum of **S\$20 in a single transaction** from now till 30 June 2024 will be rewarded with S\$10 cashback (**“Prize”**), on top of their usual Qualifying Card cashback.

Qualifying ICBC Credit Cards (“Qualifying Card(s)”):

- a) ICBC Student Talent Credit Card
- b) ICBC Horoscope Credit Card

Eligibility Criteria:

This Promotion is open to ICBC Credit Card Cardmembers of ICBC Singapore who satisfy the eligibility criterias below (**“Eligible Cardmembers”**):

- a) this promotion is applicable to ICBC Credit Card Cardholders who received the invitation SMS and/or email from ICBC. Please note that the invitation is not transferable;
- b) your Qualifying Card has to be activated within the Promotion Period;
- c) you spend a minimum of S\$20 in a single transaction to your Qualifying Card within the Promotion Period; and
- d) your Card account is active and in good standing with ICBC Bank from the start of Promotion Period until point of fulfilment.

ICBC Singapore Terms and Conditions

1. By participating in this Promotion, you agree to the terms and conditions set out below (including any amendments to the terms after this).
2. The Promotion is valid during the Promotion Period.
3. The S\$10 cashback are in limited quantity and based on first come first served basis.
4. Each Eligible Cardmember is entitled to a maximum **ONE (1)** Prize upon meeting the terms and conditions of this Promotion.
5. Upon satisfying the Eligibility Criteria, the cashback will be credited to the Eligible Cardmember’s Qualifying Card within 45 working days after the end of the month that the Qualifying Transaction was reflected on their Qualifying Card.
6. Qualifying transactions shall refer to retail transaction, online transaction and foreign currency transaction charged to the Card and posted during the Promotion Period. For the avoidance of doubt, if transaction was made on 30 June 2024 and posted on 1 July 2024, this transaction would not be considered as qualifying transaction under this Promotion.

7. Foreign currency transaction which is denominated in a currency other than Singapore Dollars shall be converted into Singapore Dollars based on the Bank's prevailing foreign currency exchange rates.
8. Qualifying transaction excludes the following transactions:

 - any payment to securities brokers or dealers, or any trading or forex related transactions;
 - any payment of insurance premiums;
 - any real estate related transactions;
 - school fees or any other education related fee transactions;
 - any AXS transactions;
 - any tax payments;
 - any transaction subsequently cancelled, void or reversed;
 - any payment for any outstanding balance owing on the Credit Card account from previous and/or other months;
 - any POI funding transactions;
 - any disputed transactions;
 - any tax refunds credited into the Card account (including supplementary Card account);

 - you violated the terms of your ICBC Credit Card Cardmember's Agreement; or
 - we believe or suspect that any transaction is illegal, fraudulent, dishonest, or unauthorized.
10. We shall reserve the right to disqualify Eligible Cardmembers from this Promotion if the Qualifying Card is no longer in good standing, or in circumstances otherwise determined by us as not eligible for the Promotion.
11. We shall not be liable for any failure or delay in the transmission of the transactions by any party including but not limited to merchant establishments. We shall not be liable for any late posting of the transactions thereby affecting your eligibility for this Promotion.
12. 16. These Terms and Conditions are to be read together with our prevailing ICBC Credit Card Cardmember's Agreement ("**Cardmember's Agreement**") (and may be subject to changes from time to time). In the event of inconsistencies between these terms and other terms, these terms shall prevail only to the extent of such inconsistency.
17. These Terms and Conditions are governed by Singapore law and by participating in this Promotion, you agree to submit to the exclusive jurisdiction of the Singapore courts. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
18. Our decision in all matters arising from this Promotion is final, conclusive, and binding on all participating cardmembers.
19. The promotional materials for this Promotion may be prepared in English and Chinese; in the event of inconsistency, the English version shall prevail.
